### **Parent Participation Hours (SALT)**

Twenty-five hours of volunteer time are required for each family. Volunteer hours may be served August 1 – May 31. After June 1, any un-served hours will be invoiced at a rate of \$20.00/hr. SALT stands for Serving and Laboring Together.

### **Scholarships**

We recognize that the cost of housing in the Santa Ynez Valley is exceptionally high, and tuition costs can be challenging even for families that would be considered high income in most other areas of the country. We believe that your choices in education should not be limited by financial matters, and we would like to make Christian education available to every family wishing to enroll. The Christian Academy offers financial aid on the basis of financial need and the availability of funds, and we encourage any family that may not be able to meet the standard tuition schedule to apply for a scholarship.

To provide the utmost confidentiality, we use a third party on-line application process. This third party is called "FACTS Grant and Aid Assessment." Once your application is filed, it is sent to the Scholarship Committee and processed. Applicants will be contacted by the Business Manager after their review, to discuss the results and your options. To begin the application process, visit <https://online.factsmtg.com/aid>. The scholarship application deadline for re-enrollment is April 30. The award determination process can take three to six weeks once your FACTS application has been completed. ### **Payments**

Payments not received by the 10<sup>th</sup> of each month will be charged a \$25 late fee and will be charged accordingly. Any outstanding balances from the previous school year must be paid in full before your student's re-enrollment can be considered guaranteed or they can begin attending classes.

### **Withdrawals/Dismissals**

If you decide to withdraw your student or he/she is dismissed for academic or behavioral reasons, your tuition and fees will not be refunded and you will be responsible for the remaining portion of tuition as outlined in the school financial policies. A withdrawal form must be completed and returned to the School Office.
